 donation to the Semper Fi Fund to support the US Marine Corps.
- Helen will arrange to complete the audit for last year's finances.
- Helen asked Dave to get thumb drive to her for updating the club's financial files.
- Stu inquired if we have a need for cloud back up of club documents of any sort. Dave has a
 drop box account he uses to save competition documents. Board felt there is not enough
 documentation to warrant paying for a cloud backup service.

The Programs / Workshops Report:

- Upcoming meetings include:

 - ✓ 2/28 Image editing demonstration using selected club member images to show how to make them more competitive in competitions. Will be facilitated by Dave and Val.
 - ✓ March there are no programs current scheduled for March.
 - √ 4/1 Bronx Zoo field trip with Syosset Camera Club. Will try to pair up Bronx Zoo members with non-members where possible.
- Ideas and suggestions for workshops and presenters are needed. Vinnie reported that it is difficult to get presenters at in person meeting in Levittown. It was noted that many clubs are now fully on ZOOM.

 Nothing new to report. Have been responding to questions about where scores and various other things are on the site. Feel free to call Julie with any questions.

Digital Chair Report:

Dave reported.

- PFLI sizing issue was reported in an email sent to member clubs on Sunday 2/5. Resulting
 from issues at recent PFLI competition and their use of a new larger screen, resolution and
 sizing requirements are being revised effective immediately. The new sizing requirement is
 1800 pixels on the long side. The resolution setting has not been made clear but may stay at
 72. Dave will confirm and reissue the documentation for competition submissions.
- Dave reported that the short notice for the sizing change is difficult for our club because he has
 already collected images for the February competition at the previous sizing requirement.
 Dave's proposed solution is that we hold our competition as scheduled and those images that
 are selected for PHLI will be not be submitted to the PFLI competition this month. Instead, the
 image makers will be asked to resize them at the new requirement and they will be submitted to
 PFLI as makeups in their next month's competition.
- Changes in sizing requirement may allow us to bring back the competition program we were
 previously using. With the enhanced resolution requirement, the shortcoming found in that
 program may no longer be an issue. Dave will assess that as we go forward.
- Dave reported that he will be retiring from the Digital Chair role after the 2024-25 season while he and his family prepare to relocate. He will continue in the role till the end of the 2024 calendar year. The board will need to identify a replacement and Dave will begin training and transitioning to prepare for end of year turnover. Dave will remain with the club and participate with the new Digital Chairperson in January 2025 to ensure a clean and easy transition. Dave plans to stay with the club through 2025. We all appreciate Dave's time and commitment to the club and his fine work in this capacity and we wish him well.
- Ellen reported the availability of a new program that can be used to manager image submissions for competitions. More evaluation of the software will be needed if the club feels there is interest.
